Principles & Guidelines for Government Scientific Advice Workshop briefing paper – September 2016

1: CONTEXT

In November 2015, the World Science Forum (WSF) in Budapest used its concluding declaration to make a specific request for a set principles and guidelines to underpin science advice.¹ An extract of that declaration reads:

“The need to define the principles, processes and application of science advice and to address the theoretical and practical questions regarding the independence, transparency, visibility and accountability of those who receive and provide advice has never been more important.....We call for concerted action of scientists and policy-makers to define and promulgate universal principles for developing and communicating science to inform and evaluate policy based on responsibility, integrity, independence, and accountability.”

To respond to this request, INGSA is organising a series of roundtables and workshops for practitioners, policymakers, ethicists, policy, legal and STS scholars to develop a draft set of principles and guidelines, before seeking endorsement at the World Science Forum in Jordan in late-2017. There will also be an electronic consultation via the INGSA website.
